"KUBOTA PBR WORLD FINAL SWEEPSTAKES – LAS VEGAS NOVEMBER 2022" SPONSORED BY KUBOTA TRACTOR CORPORATION

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE FIFTY UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE INELIGIBLE AND NOT LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY.

1. Entry Period: The "Kubota PBR World Finals Sweepstakes- Las Vegas November 2022" ("Sweepstakes") commences at 12:00 AM CT on April 1, 2022 and ends at 11:59 PM CT on September 30, 2022 ("Sweepstakes Period"). The Sponsor's time clock will be the official time keeping device for this Sweepstakes. All entries must be received by 11:59 PM CT on September 30, 2022. All interpretations of these Official Rules and decisions made by Sponsor relating to the Sweepstakes are final.

2. Eligibility: The Sweepstakes is open to U.S. citizens and U.S. resident aliens who are physically located in and legal residents of one of the 50 United States or the District of Columbia who are at least the age of majority in their state of residence at time of entry: 18 years of age in most states, 19 in Alabama and Nebraska, 21 in Mississippi. Employees, agents, directors of Kubota Tractor Corporation ("Sponsor" or "Kubota") and their parent companies, affiliated companies, subsidiaries, joint ventures, partners, agents, dealers, manufacturers, distributors, sponsors, advertising agencies, promotion and administration agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes ("Released Parties"), and their immediate families (*i.e.*, parents, spouse, siblings, children, grandparents, step-parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to enter Sweepstakes.

By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor and by the decisions of Sponsor; (b) acknowledge compliance with these Official Rules; (c) represent and warrant that entrant meets all the eligibility criteria set forth in these Official Rules; (d) agree to comply with any and all applicable federal, state and local laws, rules and regulations; (e) acknowledge that Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Facebook; and (f) agree to indemnify and hold harmless Released Parties and Facebook from and against any and all liability arising out of or relating in any way to entrant's participation in Sweepstakes and to release all rights to bring any claim, action or proceeding against Released Parties and Facebook. This includes, but is not limited to, any and all claims, demands, damages and causes of action for personal injuries, exposure to infectious disease, illness, or death and/or damage to personal or real property, theft, loss or any other harm, suffered directly or indirectly from entrant's participation in Sweepstakes or the receipt or acceptance, redemption, possession, use or misuse of the Prizes (hereinafter defined), and for any claim including claims based on defamation, publicity rights, invasion of privacy, copyright infringement, trademark infringement, or any other intellectual property related or other cause of action.

3. To Enter: There are three (3) methods of entry.

To Enter at a Kubota Field Event: To enter via this method of entry, entrant must: (i) attend any of the Kubota Field Events taking place between April 1, 2022 and September 30, 2022 ("Event(s)"); (ii) visit the Kubota booth at the Event ("Booth"); (iii) access the Sweepstakes application by using the specified handset provided at the Booth for registering for the Sweepstakes; and (iv) complete all required fields on the entry form, including agreeing to the Official Rules, and submit as required and receive one (1) entry into the Sweepstakes. Only fully completed entry forms are eligible. Visit <https://www.kubotausa.com/events> to confirm the exact date, time and location of each Event.

To Enter Online: To receive one (1) entry into this Sweepstakes: (i) visit <https://info.kubotausa.com/PBRSweepstakes> and complete all required fields on the online entry form, including agreeing to the Official Rules; and (ii) submit entry form as instructed. Only fully completed entry forms are eligible. Message and data rates may apply if entrant enters Sweepstakes via mobile device.

To Enter via Facebook: This method of entry will be available commencing at 12:00 AM CT on July 1, 2022. In order to enter via this method of entry, entrant must: (i) log onto their Facebook account; (ii) find the Sweepstakes ad posted from Kubota Tractor Corporation; and (iii) click on the form and follow the instructions to enter the Sweepstakes and submit entry as required to receive one (1) entry into Sweepstakes. Entrant will need to have a valid Facebook account in order to enter Sweepstakes via this method of entry. Entrant can open a Facebook account for free by registering with www.facebook.com. **Entrant must not use more than one (1) Facebook account to enter Sweepstakes via this method of entry. If an entrant is suspected of using multiple Facebook accounts to enter Sweepstakes, any entries received by such means will be void. Entrants must accept and be in compliance with the Facebook Terms and Conditions and accept the Facebook Privacy Policy. Message and data rates may apply if entrant enters Sweepstakes via mobile device.**

AGREEMENT TO OFFICIAL RULES: By participating in Sweepstakes, entrants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor and its agents, which are final and binding in all matters related to the Sweepstakes.

All information submitted to Sponsor by entrants is subject to and will be treated in a manner consistent with Sponsor's Privacy Policy accessible at <https://www.kubota.com/privacy/index.html>. By participating in Sweepstakes, entrants hereby agree that Sponsor may collect and use their personal information in compliance with its Privacy Policy and acknowledge that they have read and accepted the Sponsor Privacy Policy. All information submitted by entrants is being provided to Sponsor and/or Sponsor's promotion agency and not to Facebook.

There is a limit of one (1) entry per person, regardless of method of entry. If it is suspected that an entrant submits more than one (1) entry, only one (1) entry will be considered. In the event of a dispute over who submitted a winning entry, the "authorized account subscriber" of the e-mail account used to participate in Sweepstakes at the actual time of entry, will be deemed to be the entrant. **It is the sole responsibility of the entrant to notify the Sponsor in writing if the entrant changes their email address during the Sweepstakes Period.** The "authorized account subscriber" for online entries is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted e-mail address. In the event a winning account selected is a joint account, a total of one (1) Prize will be awarded in the name of the first-named account holder. Proof to Sponsor's satisfaction of being the authorized account subscriber may be required by Sponsor.

All entries submitted in compliance with these Official Rules and not disqualified are considered "**Eligible Entries**". Entries that are not in compliance with these Official Rules will be disqualified at Sponsor's sole and absolute discretion. All entries become the sole and exclusive property of Sponsor. Entries will not be returned, and receipt of entry may not be acknowledged. Proof of entry will not be deemed to be proof of receipt of entry by Sponsor.

4. Odds: The odds of becoming a Sweepstakes Winner (hereinafter defined) depend on the total number of Eligible Entries received during the Sweepstakes Period.

5. Prizes: The Winners will receive a trip for the Winner and one (1) guest of Winner ("**Guest**"), to Las Vegas, Nevada ("**Destination**") to attend the PBR World Finals ("**Event**"), on November 4 – 6, 2022, but subject to change in Sponsor's sole discretion. The trip will include: (i) round trip coach class air transportation on the airline of Sponsor's choice for Winner and Guest which shall originate from an airport of Sponsor's choice near Winner's primary residence in the United States to Destination, with an approximate retail value ("**ARV**") of \$1,560; (ii) two (2) nights hotel accommodations in Destination for Winner and Guest, which will be one (1) standard room based on double occupancy

(meals, telephone calls, mini-bar, tips, gratuities, and other incidentals and costs are not included), with an ARV of \$900; (iii) two (2) tickets to a VIP experience at the Event, including tickets to the Event, with an ARV of \$1,150; (iv) one (1) prize pack consisting of Kubota/PBR branded merchandise, with an ARV of \$100; and (v) one (1) \$500 pre-paid gift card (subject to the terms and conditions of the gift card, with an ARV of \$500, collectively (the "Prize" or "Prizes"). The total ARV of each Prize per Winner is \$4,210. Prize consists of only the elements specifically listed as part of the Prize. Sponsor reserves the right to substitute ground transportation in lieu of air transportation if the Winner resides within 100 miles of Destination and no compensation or substitution will be provided for the difference in Prize value. Winners and Guests must travel on the same itinerary.

The total ARV of all of the Prizes is \$8,420. The ARVs are subject to change based on current market conditions at time of Prize fulfillment, and the time of travel and the distance between departure and Destination. Any difference between the ARVs and the actual values, if any, will not be awarded.

Choice of ticket seat locations for the Event to be determined by Sponsor in its sole discretion. Winners and Guests are responsible for all costs and expenses associated with Prize acceptance and use that are not specified herein as being awarded. Prize dates are subject to change in Sponsor's sole discretion. If a Winner is not available or able to accept the Prize, Winner privileges will be terminated, and an alternative Winner may be selected from among the remaining Eligible Entries received if time permits.

PLEASE MAKE NOTE THAT THE PRIZE MUST BE TAKEN IN ITS ENTIRETY IN ORDER TO AWARD ANY ELEMENT OF THE PRIZE. IF A WINNER DOES NOT, FOR ANY REASON, ATTEND THE TRIP, THE GIFT CARD AND PRIZE PACK PORTIONS OF THE PRIZE WILL NOT BE AWARDED.

Winners and Guests must comply with all requirements for proper and appropriate behavior during any Prize related activities or events. Each Winner understands and agrees that Sponsor has the right, at their sole discretion, to disqualify and remove any Winner or Guest from any activity at any time without compensation if such person's behavior at any point is uncooperative, disruptive, or may or does cause damage to person, property, or the reputation or business of Sponsor or otherwise violates the policies of the Sponsor, as determined by Sponsor in its reasonable discretion.

6. Publicity Release: By participating in Sweepstakes, each Winner grants to Sponsor, and its representatives, affiliates, licensees and assigns, the right and permission to record, film, videotape and photograph the Winner ("Images"). These Images will be owned by Sponsor. Sponsor and each of its designees shall have the right to use, re-use, reproduce, publish, display, exhibit, distribute, edit, adapt, post, stream, copy and exploit such Images, and all elements embodied therein, including any names, likenesses, address, voice, conversation, biographical and Prize information and any other attributes of Winner, individually or with others, in whole or in part, in conjunction with other material, if any, in any and all media now known or hereafter devised, for the purpose of trade, advertising, publicity, promotion, or a Sweepstakes Winner List or any other lawful purpose whatsoever, in perpetuity, throughout the world, without additional compensation, consideration, notification or permission, except where prohibited by law.

7. Winner Selection and Notification: There will be two (2) Winners selected in a random drawing from among all of the Eligible Entries on or about October 12, 2022 by Sponsor's independent designated Sweepstakes administrator who will also attempt to contact the potential winners via the telephone number or email address provided at time of entry and by entering the Sweepstakes the entrant hereby grants permission to be contacted via telephone or email. **No messages will be left on answering machines or voicemail systems.** If a potential winner cannot be reached directly and/or does not meet the eligibility requirements, the potential winner will be disqualified, and an alternate potential winner will be selected in a random drawing from among all of the remaining Eligible Entries. Released Parties are not responsible for false, incorrect, changed, incomplete or illegible contact information or other unsuccessful attempts to notify potential winners.

8. Winner Verification: To be eligible to be declared a Winner and to receive the Prizes, the potential winners must sign and return to Sponsor and/or Sponsor's designated Sweepstakes administrator, within three (3) days of issuance of such documentation, a complete and valid IRS Form W9 and an Affidavit of Eligibility and Release that: (a) releases Released Parties and Facebook from any and all liability, loss, claims, demands, and causes of action for exposure to infectious disease, illness, personal injuries or death and/or damage to personal or real property, theft, loss, or any other harm suffered directly or indirectly from potential winner's participation in Sweepstakes, including, but not limited to, traveling to, preparing for and/or participating in any Prize related activity, or the acceptance, possession, or use or misuse of any Prize; (b) except where prohibited by law, grants Released Parties the right to use potential winner's name,

picture and/or likeness, or biographical information or voice for trade, advertising and publicity purposes, in any media now known or hereafter devised, throughout the world, in perpetuity, without additional compensation or consideration or notification; and (c) any other document, release or waiver deemed necessary. Entry into Sweepstakes constitutes agreement to sign such release, waiver or other documentation. If a Winner does not sign the documentation as specified in this Section and return the documentation within the time frame specified, the potential winner may be disqualified, and the Prizes forfeited. When such documentation is properly executed and providing potential winners are otherwise in compliance with the Official Rules, potential winners will each be determined to be a Sweepstakes winner ("Winner" and collectively "Winners").

Guests participating in Prize with Winners will also be required to sign [the Guest's parent or legal guardian if Guest has not reached the age of majority in the jurisdiction in which they reside ("Minor")], a Liability/Publicity Release that must be returned along with the potential winner's documentation as provided in these Official Rules within three (3) days of issuance. If any Guest is a Minor, Guest must be accompanied by their parent or legal guardian and such parent or legal guardian must be the applicable Winner. If a Winner chooses not to take a Guest, or if any Guest does not sign the documentation as provided in these Official Rules within the time frame specified, then the Guest elements of the Prize will be forfeited, and the other elements of the Prize shall constitute full satisfaction of Sponsor's obligation to award the Prize. Prizes will be forfeited if a Winner or a Guest fails to comply with the terms and conditions of these Official Rules. Winners and Guests agree to comply with all venue rules and regulations and agree not to act in an unsportsmanlike or disruptive manner.

To the extent permissible by law, Sponsor reserves the right to require potential winners to submit to a confidential background check to confirm eligibility and help ensure that the use of any such person in advertising or publicity for the Sweepstakes will not bring Sponsor or any other Released Party into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sweepstakes as determined by Sponsor, in its sole discretion. Potential winners must agree to sign waiver forms authorizing the release of personal and background information. Sponsor reserves the right, in its sole discretion, to disqualify potential winner based on the background check.

If a potential winner is unable to participate in or accept the Prize or any portion of the Prize for any reason, Sponsor will have no further obligation to the potential winner. Prize or Prize documents returned as undeliverable will result in forfeiture of Prize. Sponsor expressly reserves the right to delay the announcement of the Winners for any reason Sponsor deems necessary. In addition, Sponsor reserves the right to select an alternate Winner in the event that any potential winner fails to comply with these Official Rules or fails to execute the documentation within the time frame specified.

By participating in Sweepstakes, Winners and Guests acknowledge that Released Parties have not and will not obtain or provide insurance of any kind relating to the Prizes and that Winners and Guests will be responsible for obtaining and paying for any form of insurance relating to the Prizes that Winners or Guests deem appropriate.

9. Prize Terms: The dates for fulfillment of the Prizes will be on or about November 4 -6, 2022, but subject to change in Sponsor's sole discretion. If for any reason any Prize is unavailable or any Prize or related event is delayed, cancelled or postponed, or for any other reason, Sponsor reserves the right to modify the Sweepstakes in its sole discretion and award a substitute Prize, or portion of Prize, of comparable or greater value as set forth in these Official Rules. No substitution, transfer, assignment or cash equivalent of the Prize, or any portion thereof, is permitted by a Winner or a Guest. Released Parties shall have no responsibility or obligation to a Winner or a Guest who is unable or unavailable to, or who does not for any reason, accept or utilize the Prizes. All Prize details not specified in these Official Rules will be determined by Sponsor's in its sole and absolute discretion. The Released Parties are not responsible for and will not replace any lost, mutilated or stolen Prizes or any Prize that is undeliverable or does not reach the Winner because of an incorrect or changed address. All costs and expenses not specifically listed above as part of the Prizes, including, without limitation; passports or other travel documentation, transportation (unless specified as being included), meals, snacks, beverages, mini-bar, entertainment, tips, gratuities, souvenirs, personal expenses, damages to hotel rooms, baggage fees, travel insurance, departure taxes and fees, and any equipment to be used in connection with the Prizes, are solely Winner's responsibility. The Winner may be required to provide a credit card to the hotel to cover any incidental costs incurred. SOME JURISDICTIONS MAY NOT

ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES SO SOME OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. CHECK YOUR LOCAL LAWS FOR ANY RESTRICTIONS OR LIMITATIONS REGARDING THESE LIMITATIONS OR EXCLUSIONS. Winners agree to look to the manufacturer for any defect or warranty problems. Prizes must be accepted as awarded. Any Prize manufacturer is not a sponsor of this Sweepstakes and is not affiliated with Sponsor. Prizes pictured in online, television, print advertising, and other Sweepstakes materials are for illustrative purposes only. Arrangements for the fulfillment of the Prizes, including all travel arrangements, will be made by Sponsor's designated promotion agency and/or Sponsor.

Sponsor will determine in its sole discretion the airline and hotel to be provided as part of the Prize. All travel dates are subject to change in Sponsor's sole discretion. If a Winner or a Guest is not available or able to travel on the dates specified by Sponsor, Winner and Guest's privileges will be terminated and an alternative Winner will be selected in a random manner from the remaining Eligible Entries if time permits. Travel restrictions, conditions and limitations may apply. Travel arrangements are subject to availability and must be roundtrip. Released Parties shall not be responsible for any damage to baggage or any cancellations, delays, diversions or substitutions or any acts or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any element of the Prize or associated with the Prize. Winners and Guests must possess valid travel documents in order to travel.

10. Taxes: All Winners with Prize values of \$600 or over must supply Sponsor and/or Sponsor's designated Sweepstakes administrator with their social security number. An IRS Form 1099 will be issued in the name of Winner for the actual value of the Prize awarded if the actual value of Prize is \$600 or over. If, for any reason Sweepstakes is not capable of running as planned, including, without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of Released Parties, which, in Sponsor's sole determination, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend Sweepstakes or any part of the Sweepstakes. If Sweepstakes or any part of the Sweepstakes is terminated or modified prior to the closing date of the Sweepstakes, notice will be posted on <https://info.kubotausa.com/PBRSweepstakes>. If time permits and the Prizes will be awarded to Winners to be selected in a random drawing from among all of the remaining uncorrupted Eligible Entries received prior to any such event, or in any manner that is fair and equitable as determined by Sponsor in its sole discretion. Sponsor reserves the right to modify and amend these Official Rules from time to time during Sweepstakes for clarification purposes. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Released Parties assume no responsibility for and will disqualify entries that are: stolen, late, lost, illegible, incomplete, invalid, unintelligible, altered, tampered with, unauthorized, fraudulent, damaged, destroyed, delayed, misdirected, not received, postage due mail entries, or that have incorrect or inaccurate entry information, whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes, or by any human, mechanical or electronic error that may occur in the processing of the entries in Sweepstakes, or other errors appearing within the Official Rules or in any Sweepstakes related advertisements. Sponsor reserves the right in its sole discretion to disqualify any person they suspect or find: (i) to have used a software generated, robotic, programmed, script, macro or other automated entry; (ii) to have tampered with the entry process or the operation of Sweepstakes; (iii) to be acting in a disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; (iv) to display behavior that will bring such Winner or Released Parties into disgrace; (v) to have provided inaccurate information on any legal documents submitted in connection with Sweepstakes; or (vi) to be acting in violation of these Official Rules. ANY VIOLATION OF THESE OFFICIAL RULES BY A WINNER WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS A WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS A WINNER WILL BE IMMEDIATELY TERMINATED.
